

Updated January 19, 2024 HOOK & PADDLE Competition Rules Standard

The terms and conditions presented in this document apply between Hook & Paddle (H&P) and those persons registering for and participating in H&P competitive Events ("Competitor"). The pronouns "he," "him," "himself," and "his" herein are used as generic, gender-neutral terms and do not restrict or confirm access on the basis of sex.

Each H&P Event, (referred to herein as "Competition") is a CPR (Catch-Photo-Release) contest in which each Competitor catches his own fish in places, during times, and by procedures permitted in all pertinent rules and regulations, digitally photographs them according to the standards described herein, and submits the lengths and photographs for verification. These Competitions are conducted according to H&P Competition Rules found in two documents:

A. *H&P* Competition Rules Standard (this document) covers about 90% of the terms, conditions, and standards common to all H&P Events.

B. Event-specific rules are located on the H&P event-specific webpage, which includes details such as dates, locations, times, eligible water boundaries, restrictions, and exceptions to the H&P Rules Standard.

Together, this document and web page (<u>www.hookandpaddle.ca</u>) comprise the *H&P Competition Rules*. As a condition of participation in any H&P Competition, the participating angler ("Competitor") agrees to read, understand, and comply with all H&P Competition Rules. Failure to comply will result in a penalty, which may range from points deductions to photo submission denial or disqualification from the event.

For each Event, the H&P Event Coordinator and/or Tournament or Series Director ("TD") will be identified on the H&P event-specific page. The Tournament Director and/or Director of Operations has responsibility for the interpretation and enforcement of the H&P Competition Rules and may amplify or clarify them to make them more relevant or complete. Tournament Director and/or Director of Operations decisions may be disputed, as described in Section 17.A. H&P management will review the decisions and revise the H&P Competition Rules appropriately.

Announcement of any rule changes will also be posted as soon as possible and will be effective immediately upon publishing in the H&P Facebook Page and the H&P Website. H&P will notify all competitors via all available

methods of communication above. Understanding and being aware of the most recent rules prior to engaging in any competition or event is the sole responsibility of the competitor.

1. Participation and Eligibility

A. Event Registration – All H&P competitors must register and pay for each event online at the <u>Hook And</u> <u>Paddle – Canada's Premier Kayak Fishing Series</u> website.

 Event specific H&P tournament ID will be issued by H&P Tournament Director on the morning of but prior to event start time. This Tournament ID must be included when submitting photos. (see 9. I. Photo Submission)

B. Entry Fees

- 1. Entry fee amounts, registration deadlines, late fee exceptions, and refund are specified on the event-specific page for each competition.
- 2. No Satisfaction Guarantee Competitor understands and agrees that payment for the event does not secure a guarantee or promise of satisfaction.
- 3. Competitor's failure or inability, for any reason except as otherwise provided herein, to participate in any or all of the activities of the event does not relieve or suspend the Competitor's obligation to make all payments required by H&P rules on a timely basis, nor entitle the competitor to a refund or credit, except as provided below.

C. Payment – Competitor agrees that once an event registration is submitted, the terms and conditions of the H&P Competition Rules constitute an agreement that is a legally binding and an enforceable obligation of the Competitor.

D. Competitor's Right to Cancel – Cancellation before an event registration deadline, will be eligible for full refund or credit to be applied towards another H&P event with 48hr prior notice. If a H&P event is canceled, anglers will be fully refunded, or the entry fee can be credited towards another H&P event. H&P is not responsible for any refunds of expenses related to travel or lodging reservations or other payments involving third parties.

2. Fish Eligibility

A. *Species* – The following species are eligible for the Hook & Paddle series - Catfish (Brown Bullhead), Chain Pickerel, Chub/Fallfish, Eel, Trout (any species), Muskie, Pumpkinseed Sunfish, Redbreast Sunfish, Gaspereau, Striped Bass, Smallmouth Bass, Largemouth Bass, Sturgeon, Sucker, White Perch, Yellow Perch.

B. *Length* – There is no minimum length for any species that can be scored in competition unless otherwise specified in event-specific rules.

C. *Condition* – Fish may not appear to be dead, mutilated, frozen, mangled, or otherwise damaged, or it appears to have been mashed, mauled, or otherwise altered.

D. Fish Entry is based on events. Only fish landed within tournament hours for the specific event or day may be submitted. **See Photo Standards (Section 9) and Scoring (Section 10) for additional requirements.**

3. Competition Period

Competition start and end dates and times are stated on the event-specific page. Competitors may place their watercraft in the water, occupy them, shove off, and then stage (float, drift, or anchor) in the immediate area until the official "Shotgun Start" horn which will be blown by the Tournament Director, no angling may commence until this Horn has been sounded. **Violation will result in penalties (see Penalties section 11 below).**

4. Pre-fishing

Pre-fishing is considered to be any activity that takes place on eligible water defined in the event-specific rules including fishing, scouting, and graphing. At the end of the pre-fishing time specified in the event-specific rules, the angler must be off the water. There are no restrictions regarding areas and types of watercraft used in pre-fishing. **Effective 2022:** Anglers may **not** pre-fish eligible waters for any H&P Series event 24 hours prior to the event or series competition date(s) and time. **Violation will result in penalties (see Penalties section 11 below).**

5. Competition Area

A. Competitive fishing is allowed only on publicly accessible waters within the geographic area designated on the Event Page as "Eligible Water" or "Tournament Boundaries". Photos of fish caught outside of eligible water boundaries will be denied.

- 1. Photos that competitors submit for scoring in every H&P Event or tournament must be of fish caught from Eligible Water. To be "Eligible," the body of water must be inside the competition area boundary, during public-access hours, be accessible to the public, and be where fishing is permitted by regulations.
- A competitor must access the water from or across publicly accessible areas or rights-of-way. Additionally, anglers MUST NOT cast into or otherwise obtain access to off-limits areas from eligible water. (Example: Casting into out of bounds areas while kayak is sitting inside tournament boundaries.)
- 3. Clarification of eligible waters is the sole responsibility of the competitor prior to engaging in competition.

B. Competitors must launch from the designated launch indicated on the event page for each specific tournament directly onto Eligible Water. Crossing restricted property to reach Eligible Water is not permitted. Tributaries, canals, sloughs or estuaries separated from the rest of eligible water by temporary obstructions (e.g., fallen trees, log jams, beaver dams) that, if removed, could be entered by floating/paddling are considered eligible waters in which competition is permitted, and competitors are permitted to drag or portage watercraft over or around such obstructions. Those separated by obstructions of a permanent nature across or through which one cannot paddle/float (e.g., levees, earthen or concrete dams, berms, elevated roadbeds,

spillways, waterfalls) are ineligible water, and competition in such areas is prohibited. **Violation will result in penalties (see Penalties section 11 below).**

C. Competitors are not permitted to relocate to other eligible waters during tournament hours. Competitors may finish the tournament at a public location other than the "Launch", as long as photos are submitted before the deadline. Tournament Director will continue with awarding prizes in a timely manner, and will not wait for competitors that choose to finish at a different location. Competitors are responsible to allow proper time to pack and travel to the awards presentation, if absent, any prizes won will be forfeited.

D. Watercraft must not be anchored in such a position as to prevent or block access for other watercraft or powerboats.

E. Competitors must not tie or secure themselves to docks. Anchoring off of, but adjacent to docks is acceptable as long as compliance with Section D of this clause are adhered to.

F. Fish caught in eligible water while wading or walking on the shore are **not** eligible for submission

G. Competitors' watercraft must be launched before fishing from. "Launched" means placing the watercraft on liquid water, occupying it, and going underway. NOTE: at no time may competitors photograph fish on their vessel while it is on their vehicle or trailer.

- 1. Competitor must pedal, paddle, or power his watercraft to the fishing location.
- 2. Competitor's watercraft must be visible in every fish photo submitted. Any Competitor who goes out of sight of his watercraft for any reason (e.g., restroom break, seeking or rendering aid, or reporting an emergency) must cease competition fishing and resume it only after re-launching the watercraft.

Violation will result in penalties (see Penalties section 11 below).

6. Communication, Cooperation and Assistance

NOTE: Casual verbal conversation with recreational anglers while on the water does not constitute cheating or violation of this rule. Competitors **MUST not** use electronic devices or yelling to other competitors to communicate fish location or species caught to other anglers during an event. Competitors **Must not** solicit or provide information during these conversations or interactions. If information is solicited, then competitors may submit a complaint through the Disputes process (see Section 15. Disputes) **Violation will result in penalties (see Penalties section 11 below).**

Before and during the event, competitors may:

- 1. share gear, tackle, and equipment
- 2. assist in photographing a fish for submission

3. communicate with and fish in proximity to other people, including other Competitors

Competitors may **not** receive assistance in catching fish that are photographed and submitted for scoring, including casting, retrieving, hooking, playing, or landing a fish. **Violation will result in penalties (see Penalties section 11 below).**

7. Fishing Tackle, Equipment, Methods and Measuring Boards

A. All fish submitted for score must be caught live by the Competitor who submits them for scoring using only equipment and legal methods that comply with all sportfishing statutes and regulations of the province and body of water in which they are taken. Competitors are responsible for research of and compliance with all applicable fishing and boating regulations.

B. Snatching or snagging fish is not permitted, all species must be hooked inside the mouth to be eligible. Fish must be caught, photographed, and released prior to resuming fishing (unless otherwise stipulated on the webpage for the specific event such as tidal waters where multiple rods are allowed). If you have 2 lines in the water, and catch fish on both lines, competitor must deal with both fish before lines return in the

water. Violation will result in penalties (see Penalties section 11 below).

C. All fish must be caught by the Competitor on rod, reel, line, and hook, on the tournament day. No traps, snares, set lines, or other methods of fishing other than rod, reel and line are permissible.

- 1. Live bait is permitted (worms, cut bait).
- 2. No whole fish species or minnows are permitted.

Violation will result in penalties (see Penalties section 11 below).

D. Acceptable measuring boards must be approved by Tournament Director/Administrator prior to all H&P competitions. Preferred boards may include but not limited to: Aluminum Ketch Products Measuring Board, the Ketch Karbonate (plastic), Hawg Trough and FishStik. (try to avoid **black** or dark boards)

- Measuring boards may be shortened only by removing inches from the upper end (opposite the fence). For example, one may cut off the end of a measuring board at the 26-inch mark in order for it to fit crossways between a watercraft's gunwales. However, it may not be broken, snapped, or cut apart and then reassembled at any point between the two ends. Violation will result, at minimum, in denial of the photo submission.
- 2. A slight flex in a measuring board resulting from a fish's weight is allowed; however, Competitors are prohibited from deliberately flexing or deforming a measuring board by exerting pressure or reshaping it. Any modification of a measuring board that results in a misrepresentation of a fish's actual length is grounds for a competitor's disqualification from the event and may result in subsequent sanctions and penalties as described in Rule 11.
- 3. A clean measuring device is expected to ensure we can give you a proper score.
- 4. Competitors may share measuring boards.
- 5. If using the FishStik, a hook may remain in the fish's mouth if it can slide in the slot at the head of the bump board, allowing the jaw/mouth to make contact with the board without restriction. Any fish not touching the bump board will result in reduction of points or possible denial of photo submission.

E. Technology (Cell Phones) – Each competitor is responsible for having the necessary technology with GPS, location, and capture capability.

1. When a Competitor's technology becomes inoperable or is lost, he may share with other Competitors, provided each Competitor submits their own catches. Unique event identifier must be included in each photo. Competitors under the same circumstances may share technology, provided each Competitor can clearly and positively identify photos of the fish he caught. **Violation will result in denial of photo submission.**

F. Only **ONE** casting, spin-casting, spinning, or fly rod and reel may be in use at any one (unless otherwise stipulated on the webpage for the specific event such as tidal waters where a maximum of **TWO** rods are allowed). A rod and reel are considered to be "in use" when a lure attached to it by a line is in or on the water. A hung lure (one snagged in an overhanging tree) that is not in or on the water is not considered in use and the attached rod and reel may be set aside while another is in use. **Violation will result in penalties (see Penalties section 11 below).**

G. Nets and grippers (e.g., Fish Grip, Boga-Grip) may be used for landing fish during tournament competition, but grippers must **not** remain attached to the fish in photos. **Violation will result, at minimum, of 1**" **reduction in overall length of submitted photo.**

Fish must not be retained on stringers or in live wells, other than to momentarily revive the fish. **Violation will** result in penalties (see Penalties section 11 below).

8. Watercraft & Propulsion

A. Watercraft acceptable for use in H&P Competition are those manufactured and marketed as canoes, kayaks, or SUPs for which paddling, pedaling or battery-operated trolling motors are the primary means of propulsion. Any other watercraft must be submitted to the H&P Director of Operations for review and approval prior to use in competition.

Use of watercraft in competition other than those listed above as acceptable or without prior approval will result in disqualification from the event.

B. Watercraft propulsion is restricted to paddle, pedal, pole, or electric motor.

C. Unless specifically prohibited on the event-specific page, use of a **single** electric propulsion unit per watercraft in H&P competition is approved with the following restrictions: NOTE: No more than <u>one</u> electric motor may be installed on competitor's watercraft at any time during official competition times.

D. Competitors must comply with all boating regulations pertaining to motorized kayak/electric propulsion watercraft registration, use, and operating restrictions for the designated fishing area. **Violation will result in disqualification from the event**.

E. Towing, transport, or relocation assistance from another watercraft, including "mother shipping," is NOT permitted except in cases of emergency, as when pulling a kayak from a danger zone or restricted area. Once the emergency has ended, the Competitor may resume fishing only if the watercraft was pulled no more than 100 yards from the danger zone. Violation will result in penalties (see Penalties section 11 below).
F. Trolling lure(s) attached to a single rod and towed behind a watercraft while underway is permitted in H&P Competition, anglers can have up to TWO lines in the water trolling, where permitted, or one trolling, one casting. Competitors must demonstrate sportsmanlike conduct and avoid impeding other competitors or recreational anglers while trolling.

G. Anchoring of watercraft is permitted during the H&P events as long as the following apply:

- 1. It is safe to anchor
- 2. Minimum distance of 10' from another competitor
- 3. By anchoring you do not impede or block access to a waterway being used by another competitor or other boaters utilizing the same waterway.

NOTE: Multiple fish caught on the same lure, at the same time (topwater, A-Rig, etc.) may both be accepted for scoring provided all fish are caught, photographed, and released prior to resuming fishing. For this allowance to exist, both (or more) fish must be caught legally within the eligible waters and during a single cast and/or retrieve. The additional fish may be retained by lip gripper or landing net while preparing for and taking photos of each fish. Any foul hooked fish must be immediately released.

9. Photo Standards

Digital photographs of each fish submitted to judges for scoring must meet these criteria:

A. Unique – Each digital photo submitted in each Event must be of a different fish. The Judge will deny subsequent digital photos of the same fish submitted by the Competitor in an Event. Possession of multiple fish is not permitted. All fish must be caught, photographed, and released prior to resuming fishing for subsequent fish.

- 1. Only one photo of each species must be submitted for judging. Additional photos of a species already submitted will not be considered. Competitors must ensure that they contact Tournament Director in the event of incorrectly submitted photograph, in order for a second photo to be considered.
- **B. Visible/Legible** Each photo must be in focus and clear enough for a judge to:
 - 1. Verify the event ID code. The inability of the judge to verify will result in the denial of the photo submission.
 - 2. Verify the fish's condition. Fish must be releasable, free of debris and alive. Violation will result in denial of the photo submission.
 - 3. Verify the fish's length. The judge will score fish at the greatest length of which he is certain.
 - 4. Verify whether the fish's jaw or lip is in contact with the measuring board fence. The inability of the judge to verify will result in a minimum penalty of 1 inch and may result in denial of the photo submission at the judge's discretion.
 - 5. The entire fish, from its mouth/jaw to the end of its caudal (tail) fin must be visible in photos (Except where permitted to be covered by hand). In addition, at least one visible one-inch increment of the measuring board must be clearly visible to make an accurate length determination (Example. If the fish is 17.75 and the 17 is covered, the 18' mark must be clearly visible). If either end of the fish is covered or cropped off, the photo may be denied at the judge's discretion.
 - 6. Fish with a lure still in their mouth may be subject to deduction of an inch depending on the submitted photo, as it pertains to position of the mouth touching the fence of the board.

C. Centered – Camera lens positioned directly over the center of the fish's body, which contributes to accurate measurement by judges.

D. First-generation – Each digital photo must be a first-generation image (not a photo of or screenshot of another photo). Violation will result in denial of the photo submission.

E. Identifiable – H&P event ID code above, below, or beside the fish must be visible (or placed on the Competitor's hand or arm).


NOTE: *Only the H&P event ID identifier is acceptable for photo submission*. This is given out in the morning prior to each event, and must be in the picture. Violation will result in denial of the photo submission. Digitally adding or editing an ID number to a photo will **not** be accepted.

F. Background – Competitors' watercraft must be clearly visible in all eligible photographs. Violation will result in denial of the photo submission. Watercraft must have been launched and underway to be eligible for submission. Kayak may not be in or on a competitor's vehicle or trailer while photos are taken. The following exceptions apply

- 1. Competitors may beach their kayak when attempting to take a photograph of larger species such as Muskie, Striped Bass or Sturgeon.
- 2. Competitors may beach their kayak during inclement or stormy weather, but all photos must be taken on watercraft where possible.

G. Hand Position – It is recommended to take the photo with hand as close to centered on the fish as possible. Hand placement must meet the following guidelines:

- 1. No portion of the hand may enter the gill plate. Violation will result in denial of the photo submission.
- 2. Competitors hand or thumb must not be in the mouth of the fish when taking a photo for submission. **Violations will result, at a minimum, of 1" reduction in overall length of submitted photo.**
- 3. The competitor's hand must be placed to provide a clear view of the fish's eye. Obstruction or coverage of any portion of the fish's eye will result in the denial of the photo submission. Hand must be placed forward of the Caudal peduncle (fleshy, scaled part of the bass' body at the base of the caudal fin). Competitor's hand may not contact any portion of the Caudal Peduncle past the back edge of the fish's dorsal or anal fin. **Violation will result in denial of the photo submission**. (See Photo Submission Guidelines). NOTE: The photo below is for advisory purposes and indicates areas for competitors to avoid. Official scoring is based on Photo Submission Guidelines.
- 4. In place of competitors' hands, Fish can be secured to the measuring device using a strap.
- 5. Strap can only be used in the location designated for hand placement and must not be on gills or caudal areas.



The competitor's hand may only be placed behind the eye and mouth and forward of the Caudal peduncle. FISH WILL BE DENIED if any portion is covered.

H. Mouth

1. Fish's lip or jaw must be in contact with the measuring board fence (bump board, upright), and the fence must be visible in the photo. Violation will result in denial of the photo submission or a reduction in overall length determined by judges.

NOTE: This determination will be made by the judge and will only be considered for review through submission of a formal dispute.

I. Photo submission – All photos must be submitted to the H&P Tournament Director by the end of tournament hours on the day of the event. Between 3:00-3:30pm (see specific event details on the tournament page).

- 1. All images should be sent via text message to the H&P Tournament director from which each competitor received their Tournament ID at the start of the specific event. (see 1. A. 1. Event Registration)
- 2. **Only** the largest of each applicable species should be submitted for review to the H&P Tournament Director.
 - Only one photo of each species should be submitted for judging. Additional photos of a species already submitted will not be considered. Competitor must ensure that they contact Tournament Director in the event of incorrectly submitted photograph, in order for a second photo to be considered.
- 3. Only photos submitted during tournament hours will be reviewed and tallied for the specific event and leaderboard.
- 4. The fish must be caught, landed and photographed by no later than **3:00pm** for it to be eligible for submission.
 - Photos received after 3:30pm will be deemed ineligible. It is the competitor's responsibility to contact the Tournament Director if they are experiencing technical issues and photo images are not sending. It is recommended for this reason to be at the launch by the end of tournament hours.
- 5. It is recommended that All submitted entries should include the name of the species being submitted, the length as well as how many species in total in the text being sent to the Tournament Director. (ex: Yellow Perch, 10" for the individual photo. 8 species in total) this will allow judges to verify that they received 8 photos of different species.

10. Scoring

How To Win the Hook & Paddle Series

There will be several individual tournaments that make up the series, these will take place all over New Brunswick. Each tournament will be a catch, photograph and release event. Participants can enter one or all of the tournaments and are trying to catch as many different eligible species as possible. From each event, anglers will submit their best length of each species caught. You can upgrade your previous totals as the series continues at different tournaments. Upon completion of the final tournament of the series, the angler with the highest combined species length and bonus points will be crowned as the **Hook & Paddle Champion**, there will be prizes at each tournament as well for the overall winners at the end of the series.

In additions to the Top 3 Overall Series winners, we will also have an award for the angler that has the best **Fish Only** Total Length – this means the combined total of only the anglers fish lengths, (excluding any bonus points) will be the Species Length Champion. This allows any angler to focus in on specific species they want to improve at any given tournament, instead of focusing on overall series points.

How to Win Individual Tournaments

Each tournament will be a catch, photograph and release event. Participants are trying to catch as many different eligible species as possible in that tournament. From each event, anglers will submit their best length of each species caught, the lengths will be added up, and prizes will be awarded for top finishers at each tournament.

Tournament Standings are determined by the combined length of eligible species caught on tournament day. Bonus points will be awarded for the following at each tournament:

- 1 x place 10 points6th place 5 points2nd place 9 points7th place 4 points3rd place 8 points8th place 3 points4th place 7 points9th place 2 points5th place 6 points10th place 1 point
 - **a. 3** points will be awarded for catching the "Lunker Target Species" (see individual tournament details for specific target species for each event) (If anglers are tied all will receive 3 bonus points)
 - **b. 1** point for catching the Target species (see individual tournament details for specific target species for each event)
 - **c.** In the case of a tie, the anglers tied will receive the same higher bonus points example, if two anglers are tied for 5th, both will receive 6 bonus pts.

A. Fish length is determined by its caudal fin (tail fin) touching or crossing the manufacturer's quarter-inch mark (e.g., ridges, grooves) on the measuring board. If it falls short of a 1/4-inch factory mark, the length is rounded to the next lower 1/4-inch mark that the fish's caudal fin touches or crosses. In reviewing photographs, judges will visualize as accurately as possible where a 1/4-inch factory mark would be if it extended the entire width of a board and use that imaginary line to determine a fish's length. Entire caudal fin lifted away and out of contact with the board will result in denial of the photo submission.

B. If any portion of a fish's caudal (tail) fin extends off the edge of a Measuring Board surface, the score will be determined by the highest 1/4-inch measurement reached or crossed by the portion of caudal fin on the measuring board. Any portion of the caudal fin extending off the edge of a Measuring Board is not considered in scoring.

2. For longer species such as Muskie, Sturgeon or Striped bass, a measuring device can be placed adjacent to the official measuring board. This additional device must clearly start at the bump board fence and must not be obscured in any way, so a continuous measurement is visible.

3. Bullhead/Catfish and Sturgeon can be measured with their belly face down on the bump board. **C.** Tournament ranking shall be determined by the aggregate length of each species submitted by Competitor's photos remaining on the leaderboard when judging has concluded and the dispute period has closed. Unless otherwise stipulated on the event-specific page.

D. It is up to the Competitor to submit the correct pictures before tournament deadline, forgotten pictures, or wrongly submitted pictures will not be accepted after the end-of-competition photo submission time.
E. H&P judges apply the following scoring criteria to adjust measurements, approve or deny photos, and penalize photos by deducting points (length).

Item	Photo Scoring Criteria	Penalty
a. Photo	Blurry photo/length unclear: scored at the highest mark of which there is no doubt (Rule 9.B.3)	n/a
b. Photo	Blurry photo; completely unable to judge (Rule 9.B)	Deny
c. Photo	Appears to be second-generation (e.g., screen shot, photo of photo) (Rule 9.D)	Deny
d. Photo	META data does not exist and/and other evidence substantiates photo taken outside of Eligible Water boundaries (Rule 5.A)	Deny & Penalty

11. Penalties

A. In the event of any rule violation, the H&P Tournament Director may impose such penalties as deemed appropriate, including without limitation, the following: (infractions are cumulative and not isolated to a specific rule – multiple infractions of different rules will account for multiple penalties) Infractions will be recorded on each competitors record for the entirety of the tournament season.

1) Reduction of score (length) as described above or determined by the Tournament Director

- a) Penalty Structure
 - i) First offence loss of 5 points on combined series total
 - ii) Second offence loss of 10 points on combined series total

- iii) Third offence Disqualification from series and forfeiture of any funds paid or event prizes allocated to competitor.
- 2) Loss of catch for the day or up until the violation has been remedied
- 3) Disqualification from the tournament in question
- 4) Any additional penalties determined by the Tournament Director and/or Tournament Panel, including but not limited to reduction of Competitor's points and/or loss of event prizes.

Subject to the dispute and appeal processes set forth below, the Tournament Director's decisions on violations are final.

B. In the event of a photo violation, the H&P Tournament Director may impose such penalties as deemed appropriate, including but not limited to:

- 1) Reduction of length by a minimum of 1" depending on the infraction
- 2) Denial of the photo entry
- 3) Denial of the photo entry and penalty depending on the infraction (see Penalty Structure in A.1.a)

C. Following a review of the evidence, a determination by the H&P Tournament Director and/or Tournament Panel of cheating or fraud may result in disqualification from individual events or permanent suspension from all H&P series events.

D. See Section 15 Disputes

12. Awarding of Prizes

A. Prizes are determined by H&P Tournament Director

B. Prizes will be awarded after all photos submitted for scoring have been judged, the results reviewed, and leaderboard updated. Disputes submitted within the set time frame (see 15. Disputes) will be reviewed after the event and if the result of any submitted disputes affects the standings they will be updated and those affected participants will be notified and it will be posted on the H&P Facebook page regarding the change in standings only and not the complaint/dispute.

C. Product prizes (e.g., kayaks, trailers, pressure washers, lithium batteries or power-pole units) may require additional processing or delivery time.

13. Safety

A. During competition, every Competitor must have all required Canadian approved safety equipment on the watercraft. It is the responsibility of each competitor to fully understand the requirements of their watercraft. The following is a list of examples only but not limited to (e.g., light source, whistle or other audible signal devices, Canadian Coast Guard / Transport Canada or DFO approved chest-type life preserver [PFD]).

B. PFD Usage — At all times while actively engaged in competition, except as described below (Rule 13.C. PFD Wear Exceptions), the Competitor must wear a fastened Canadian certified PFD (inherent flotation or inflatable) or float jacket. A belt-style PFD, even one that deploys as a vest, is not permitted during competition. When an infraction, as described above, is verified by the Tournament Director, the competitor will forfeit picture submissions and is disqualified from the event.

C. PFD Wear Exceptions — The competitor assumes responsibility for all consequences of removing his PFD. The competitor may cease competition and remove the PFD while his watercraft is beached, anchored, or adrift only if doing so creates no unsafe condition. The competitor must put on and securely fasten the PFD before going underway or resuming competition.

If all of the following conditions exist, Competitor may briefly remove his PFD while afloat (anchored or adrift) to change, add or remove articles of clothing:

- 1. No fishing lines are in the water; and
- 2. The watercraft is not underway; and
- 3. Weather and water conditions permit one to do so safely; and
- 4. Competitor is over the age of 12.

When finished changing your attire, the Competitor must immediately put the PFD back on before going underway, fishing, or engaging in any other competition-related activity.

D. Tournament Director has the right to postpone or cancel the start of an official tournament day because of adverse weather conditions or other factors that jeopardize the Competitors' safety. Tournament waters may also be restricted at any time because of bad weather.

E. In the event of weather emergencies that pose an imminent threat to Competitors, the Tournament Director may terminate competition before the scheduled end-of-competition time. An early termination announcement with an adjusted end-of-competition time will be broadcast to Competitors via email or group text messaging. It will also be posted on social media sites. The announcement will also specify an adjusted report-in time and location. If safe to do so, upon receiving the notification, the competitor should make his way to the specified location at that time. The competitor is required to stop fishing as soon as he receives the early termination announcement. No photos of fish caught after the adjusted end-of-competitor has up to 15 minutes after the adjusted end time to submit a photo of any fish caught before the adjusted end-of-competition time/photo submission deadline.

F. In the event of an emergency, the Competitor should call 911 first and then notify tournament officials as soon as possible.

G. Use of alcohol or drugs (other than those purchased over the counter or prescribed by a licensed physician) by any Competitor **during** an Event will not be tolerated and cause for automatic disqualification from the H&P competitions. No alcoholic beverages, non-prescription stimulants, or depressants shall be allowed in watercraft during competition days.

14. Competitor Conduct

Competitors participating in any H&P event must observe the applicable rules for the Competition and must conduct themselves at all times in a manner that reflects favorably on the sport of kayak fishing, H&P, its members, or sponsors. Competitors are expected to follow high standards of sportsmanship, courtesy, integrity, safety, and conservation in support of the sport of kayak fishing, especially when in the vicinity of non-competitors who may be on or beside Eligible Water. Any Competitor who violates these principles, intentionally violates H&P Competition Rules or regulations (attempts to commit fraud), or behaves in ways that reflect unfavorably upon H&P's efforts to promote fisheries conservation, clean waters, and courtesy, may forfeit competition winnings, face suspension from future H&P competitions, be permanently banned from competition, or any combination thereof deemed appropriate by H&P.

15. Disputes

A. If a Competitor wishes to dispute a rules violation penalty, a judge's scoring decision, a Tournament Director's decision or other action that materially affected the Competitor's ranking or prize eligibility, he must submit a dispute within 24 hour (one full day) from the start of the event in question where the dispute originated. The dispute must be emailed or texted to H&P Tournament Director and include the following:

- 1. Event title, location, and date
- 2. Description or identification of penalty imposed, or condition being disputed
- 3. Reference to pertinent rule
- 4. Reason for dispute and requested action

Except for situations involving fraud or other law violations, any disputes submitted after the 24- hour dispute deadline will be reviewed without affecting the outcome of an event. No change in rank or reward will result from disputes submitted after the deadline. Only Competitors in the Event where the disputed action occurred may submit disputes. Disputes must be handled privately. All parties directly involved will be provided a copy of the dispute. The Tournament Director (for judge's rulings) or Tournament Panel (for Tournament Director rulings) will review the Competitor's claims, thoroughly investigate the disputed decision, and issue a ruling. **B.** Non-Tournament disputes can be submitted after 24 hours, but must still be submitted officially as per the process above, by stating what you want to dispute clearly. Tournament Director will then decide if a panel is needed, or if any warnings, disqualifications or disciplinary action is needed.

C. Tournament Director will rule on all disputes unless they directly include the Tournament Director in which case a Tournament Panel will be generated on the day in question or within the dispute timeframe to resolve the issues.

D. Tournament Panel will be composed of Competitors of the series. These will be randomized selections and consist of 4 competitors (unless one of the randomized selections happens to be the competitor with the dispute or the competitors for whom the dispute is being laid against).

E. Tournament Director and/or Tournament Panel rulings are final.

16. Public Comments

A. The favorable public reputation of H&P in the sport of kayak fishing, the integrity of its officials, and the reputation of its media channels are valuable assets and tangible benefits for H&P. Accordingly, it is an obligation of competitors to refrain from comments in public forums and social media or to the news media that unreasonably attack or disparage the integrity of Kayak Fishing competitions, tournament officials, sponsors, fellow members, fellow Competitors, or the H&P organization. Competitors are encouraged to express themselves and have the right to question the rules of officials. Responsible expressions of legitimate disagreement with H&P policies are encouraged, as opposed to attacks upon the integrity of the rules or officials. However, public comments that a Competitor knows, or should reasonably know, will harm the reputation of Kayak Fishing, H&P officials, H&P members or sponsors, may result in disciplinary action.
 B. Sponsor contributions will not be devalued by disputes or disagreements in public forums or social media platforms.

C. Publicly disputing a judge's ruling or any dispute decision by a H&P Tournament Director or Tournament Panel will result in the participant receiving a warning for a first offense. A repeat of the offense will result in disciplinary action up to disqualification from the current Event and permanent termination of eligibility for future H&P competitions. This provision is not intended to discourage legitimate disputes but to ensure that a fair and unbiased approach is used, and the approved challenge processes are followed in determining the best possible outcome.

17. Unavailability and Force Majeure

H&P will use reasonable efforts to hold the Event; however, under no circumstances will H&P be held responsible for unavailability caused by circumstances beyond H&P's control, including flood, fire, hurricanes, earthquakes, or other "acts of God," acts of government, civil unrest, acts of terror, strikes or labor problems nor will any Event Registration be canceled, altered or amended once the Event has commenced on the basis of circumstances beyond H&P's reasonable control.

18. HP Bass Competition

Overview:

Hook & Paddle will be continuing the concurrent HP Bass Competition for the 2024 schedule, this component will be species specific. We will have **6** tournaments that anglers will be able to submit their longest smallmouth or largemouth bass throughout the summer. Anglers can only submit **one** bass / event, at the end of the series the angler that has the longest cumulative length from their top 5 bass plus bonus points will be determined the winner.

Bass Competition Point Scoring

- Rankings determined by combined length of the anglers top 5 submitted photos from 6 eligible events.
- Anglers can submit a maximum of 6 pictures for the bass competition, one per eligible event
- Anglers will get 0.5pt as a bonus for submitting a picture of a bass at each eligible event.
- Winner of the Bass Competition will be determined by highest combined length from 5 bass plus bonus point total from all eligible events.

19. HP Elimination Bracket

Hook and Paddle strives to provide opportunities for everyone to be involved in fun competitions throughout the season, this is why in 2022 we kicked off the Inaugural Hook & Paddle Elimination Bracket. A fun competition that pairs anglers off in a head-to-head style elimination bracket.

How it works – before the first tournament of the season, anglers will have the option online via the <u>HP ELIMINATION BRACKET</u> to join in for \$5.00. This will pair them vs another angler for two tournaments, the angler that has a larger combined score (including fish lengths and bonus points) at the end of two tournaments will move onto the next round.

There will be four rounds of elimination (8 tournaments) until two anglers will face off against each other in the two day final event for bragging rights to be named the HP Elimination Bracket Winner --- oh and some awesome prizes!!

20. HP Youth Division

Overview:

Hook and Paddle wants to continue to encourage the next generation of anglers to participate in all our series. This year we will be continue our **Hook & Paddle Youth Division** – any angler age 16 or under will not have to pay any entry fees into any tournament, plus they will be eligible for Youth Angler points and prizes at every tournament. This does not mean that Youth anglers cannot compete in the main series for prizes and overall series points and prizes – they are just eligible for both!

Youth Angler Point Structure

At each tournament, youth will be eligible to receive points, based on placing that day against any youth that are in attendance. The following is the point structure for each tournament:

1 st = 120pts	5 th = 100pts
2 nd = 115pts	6 th = 99pts
3 rd = 110pts	7 th and below – 1pt from previous placement
4 th = 105pts	

Bonus Points

+ 5pts if you finish in the Top 5 overall standings at any tournament.

+ 3pts if you finish in the Top 10 overall standings at any tournament.

Winner of the youth series will be determined by highest combined point total from all eligible events.
